NEW TEAM POLICY:

What defines a Team: A team is defined as two or more WWMLS Participants or Subscribers working or acting as one for all transactions. All agents currently working as a team will be designated as a team utilizing the FLEXMLS Team format and required to fill out an application and return to the MLS Service by May 1st, 2019. All active, pended or active/w contingencies listings from the start of this new team set-up will be transferred accordingly.

<u>Creating a Team</u>: Contact the Board office for a team reporting form that will need to be filled out by your DR.

Team Guidelines: Your DR must notify the MLS Service of all team changes, including removing a member from the team, the addition of a team member, the transfer of a member to a new team, or termination of a team. Please use the Team Change Form for all necessary changes. Other guidelines are as follows:

- Participants and Subscribers may only be on one team at a time;
- Agents leaving a team will not be allowed to take any statistics;
- Once an agent is assigned to a team, no individuals listing will be allowed.
