# NEW LICENSING CYCLE / NEW EXPIRATION DATE / NEW CON-ED REQUIREMENTS

As the new licensing cycle beginning as of November 1, 2021, you will note that the date of when your license expires is no longer October 31<sup>st</sup>. It is now the date of when you were first issued your license. With this change for the licensing cycle, this also changes the con-ed requirements. In the past all Real Estate Agents were required to complete 2 hours of Legal Con-ed each year of the licensing cycle by October 31<sup>st</sup> of that year. Now with the expiration date no longer being on this date, you will need to complete 2 hours of legal con-ed by the date of when your license will expire. So, for example, if your license is set to expire on February 2, 2024, you will need to complete 2 hours of legal for this year by February 2<sup>nd</sup>, 2022, and by February 2, 2023 and by February 2, 2024.

We will note that Michigan Realtors and the Public Policy Committee are working with Legislature to get this requirement to change to a calendar year, but this is going to take some time to get the law changed. We will keep you updated on this subject.

#### First-Time Home Buyer Savings Accounts Move Closer to the Governor's Desk

Today the Michigan Senate unanimously passed House Bill 4290, sponsored by Representative Mari Manoogian (D- Birmingham). This important vote puts the bills on track to hopefully hit the Governor's desk by the end of next week. The Michigan House is scheduled to vote on the remaining piece of the bill package, Senate Bill 145 sponsored by Senator Ken Horn (R- Frankenmuth), when they return to session.

Once in law, these accounts will provide a pathway to homeownership and promote smart savings and talent retention. We thank the state legislature for addressing this important issue and a big 'thank you' to our main bill sponsors, Representatives Mari Manoogian and John Damoose, and Senators Ken Horn and Jim Runestad.
